

Through our partnership, we build upon their personal relationships and insights within the neighborhood while offering the support of our experienced staff of therapists and educators.



And finally, at Sarah’s House in Anne Arundel County, we commemorated 30 years of assisting families experiencing homelessness. My Sister’s Place Women’s Center

My Sister’s Place Women’s Center (MSPWC), marks 35 years of welcoming women and children who are experiencing homelessness to share a meal and benefit from a wide range of services. In 2008, MSPWC relocated to its current location on Cathedral Street from its original location on Mulberry Street. Since that move, My Sister’s Place has served more than 800,000 meals to women and children in need. In the past year, MSPWC’s participants made more than 22,000 visits to the Day Room to gain access to emergency services as well as case management, employment, housing, and other programs.



Gallagher Services

In Timonium, Gallagher Services celebrates 40 years of serving individuals with intellectual and developmental disabilities. In June of 1977, Gallagher Services opened its doors at its campus on Pot Spring Road. Named in memory of the former Catholic Charities Board Member, Francis X. Gallagher, the Center began as a program serving 13 children with intellectual disabilities. Forty years later, Gallagher Services supports 250 adults residentially in 50 homes throughout our community. Nine of those 250 adults were among the first 13 children at Gallagher in 1977. The Center also offers a medical day program, volunteer work and employment programs for 207 individuals. Many Gallagher individuals are presently participating in training programs, classes and partnerships to live the life of their choice.

Sarah’s House

In Anne Arundel County, Sarah’s House commemorates 30 years of assisting thousands of families who are experiencing homelessness by providing shelter and holistic supportive services. To date, Catholic Charities has served 16,027 guests, provided 1.7 million meals, and helped 3,002 families find permanent housing and employment. Our 27,000 volunteers at Sarah’s House have provided 650,000 hours of volunteer service.

Navigating a Long Road

to Parenthood

Growing up in Nigeria, adoption was not a familiar concept to Tare Youdeowei, now a U.S. citizen living in Burtonsville, Maryland. "There are many unofficial adoptions, it's often a secret," she said. Then, during a 2000 trip to visit family, she attended a celebration of a friend's adopted daughter. That planted a seed of hope which would take more than 15 years to bloom into a family.

Tare started research in earnest in 2010, eventually connecting with St. Anne's Orphanage Home in Delta State and embarking on the approvals, interviews and paperwork required by Nigeria. In 2015, she adopted her daughter, Lucia. But the process of bringing her to the United States looked as daunting as the one Tare had just completed.

When Tare found Catholic Charities Adoption Services, the agency had been working in Nigeria since 2014. To date, it has helped more than 200 families navigate Nigerian adoptions. Ellen Warnock, the program's Associate Administrator, explained, "The culture of Catholic Charities gives us permission to go into places where other agencies are less willing to go. These families invest so much to bring children out of terrible situations and give them a family. We are just a guidepost. We know the road they will have to travel. It's their journey, and we help them along their way."

Lucia stayed with Tare's family for eight months awaiting approvals for Tare to bring her to the United States. "But as soon as she came," Tare said, "none of that mattered any more. In the end all that matters is that we're here, living our life together."

After a Dangerous Journey—

Welcome



IN 2014, REPORTS BEGAN TO EMERGE OF A HUMANITARIAN CRISIS ALONG OUR BORDER—TENS OF THOUSANDS OF CHILDREN FLEEING VIOLENCE IN CENTRAL AMERICA WERE TRAVELING TO RECONNECT WITH FAMILY IN THE UNITED STATES. CATHOLIC CHARITIES HAS OFFERED SERVICES TO IMMIGRANTS IN OUR COMMUNITY SINCE THE 1960S THROUGH ESPERANZA CENTER. DIRECT SERVICES FOR UNACCOMPANIED MINORS RANGE FROM FAMILY REUNIFICATION AND LEGAL REPRESENTATION TO ENGLISH CLASSES AND OTHER SERVICES TO HELP THESE CHILDREN TRANSITION TO SCHOOL AND LIFE HERE—AS WELL AS CONNECTIONS TO RESOURCES TO HELP THEM DEAL WITH THE TRAUMA THEY’VE SUFFERED BEFORE AND ON MAKING THE DANGEROUS JOURNEY HERE.

When their mother traveled to Maryland from El Salvador in 2012 to work and help support her family, she left her three young daughters Mabel, aged 12, Maria, 10 and Gilma, 8, at home with their father. She could not know that these daughters would suffer from violence at the hands of their father and his family, who were tasked with their care.

In 2015, the girls set off to find their mother—and a life free of violence. The only point of contact the girls had for their mother was a telephone number. At a shelter for

unaccompanied minors in Houston, Texas, staff helped them reconnect with their mother, who arranged for them to travel to Maryland. Once they arrived here, Esperanza Center was able to offer free legal representation for the girls, and their attorney, Kelvin Rosado, helped their mother gain full legal custody to protect the girls from being returned to the dangerous situation they had fled.

Today, all three girls have been granted special immigrant juvenile status, and with help from Esperanza Center they are filing

applications for juvenile visas—the first step on a path to citizenship. They attend school, and the home they share with their mother is a flurry of love, learning and creative activity—drawing and painting, cooking, knitting, traditional embroidery and jewelry making. The girls dream of careers in fashion design, teaching and engineering. Their mother is grateful for the help Esperanza Center offered in providing her children with the legal foundation for a bright—and safe—future here.

When their grandson, Oliver, was born, Susan and Marlin Felmey were there to help. “It’s so expensive to live in Carroll County, it’s hard to make ends meet,” they said. So their empty nest was full again. When Oliver was 18 months old, their daughter enrolled Oliver in Head Start, and “our only complaint is that it doesn’t go to 12th grade,” Marlin said. “We have loved every minute.”

The Felmeys take every opportunity to be involved. Marlin sits on the program’s Policy Council and was recognized for his service as Carroll County Head Start Parent of the Year. It’s been a learning experience not just for Oliver, but for his grandparents, said Marlin, “I was working when my children were small, and the ideas about raising children have changed so dramatically since our day.”

Catholic Charities has operated Carroll County Head Start and Early Head Start since 2000. Today, it serves 191 families in home-based programs, its main center and two satellite locations. According to program director Patricia Foley, “poverty is everywhere—and that is why Head Start is in just about every county and state in the U.S., including Alaska and Hawaii.”

A regular presence at Oliver’s Head Start center, the Felmeys are mentors and supports for young parents, encouraging them to take advantage of resources available to them through Head Start. They are passionate advocates for a program they didn’t know existed just a few years ago. As Susan explained, “Every child deserves the same opportunities to learn and succeed.”

Giving Kids a Head Start

Rudy Boston and Shawn Haynie have been familiar faces in the Gallagher Center kitchen for more than a decade. Both men have a passion for working with and around food, and Shawn, an avid Orioles fan, has a singular focus on his version of success—a job in food service at Camden Yards.

When Gallagher Services was seeking a vendor for its meal service, Shawn and Rudy inspired a pilot vocational program with the vendor, Culinary Services Group (CSG). This move is part of a larger shift in the program's journey to a

person-centered model of planning and thinking about how to support individuals in achieving their goals and dreams. This program is one of many innovative approaches to meaningful work opportunities for adults with intellectual disabilities.

Each person's path is unique, and may include volunteer work, involvement in the Center's gardens or on a local farm and bringing vegetables to farmer's markets, making artwork or participating in a wide range of entrepreneurial ventures—designing and creating clothing, custom floor mats or

sachets and soaps from herbs grown in the Center's greenhouses.

Rudy has been a Gallagher resident since childhood. Shawn entered the program in 1994, and is a representative on Gallagher Services' strategic planning committee. This year, they graduate from training to developing additional abilities in the CSG kitchen at St. Vincent Villa—the next step in pursuing community employment. And two more residents will take their place in the training kitchen, following in their footsteps.



After the April 2015 unrest, Catholic Charities began working with Penn North Community Resource Center on an evidence-based violence prevention and interruption program—Safe Streets. Family Services Director Kevin Keegan explained, “To make a program like this work, you need to partner with a trusted community organization. Safe Streets’ success encouraged us to think differently about how we can best serve a community’s needs. Neither of our organizations would have gotten grant funding for Safe Streets without the other,” said Keegan.

Another entrepreneurial idea was also taking shape at Penn North. Ericka Alston-Buck had just started her job as PR director there, and “what everyone saw on TV was right outside our door,” she said. “The international press was here. In every interview I heard the same thing—there’s nothing for kids to do.” When she asked if Penn North could start a drop-in after-school center, she was handed keys to the vacant laundromat next door and got to work, raising money and building a program from the ground up.

As the Kids Safe Zone gained momentum, Alston-Buck realized “our children need more than hugs and high fives. This community has been traumatized.” She partnered with Catholic Charities to apply for funding for an onsite therapist. She said, “Their team understood our demographic and provided a therapist who looks like us and speaks our language. I have a relationship with these families. If we fail, it’s Miss Ericka failed me. We’re all about relationships here, and Catholic Charities has allowed us to build relationships with therapists our children can trust.”

FOR OLDER ADULTS WHO LOVE LIVING ON THEIR OWN, THE CHALLENGES OF MANAGING THE ACTIVITIES OF DAILY LIVING CAN MEAN LOSING THE INDEPENDENCE THAT KEEPS THEM THRIVING. CATHOLIC CHARITIES SENIOR SUPPORT SERVICES, A MARYLAND DEPARTMENT OF AGING CONGREGATE HOUSING SERVICES PROGRAM, HELPS MORE THAN 200 OLDER ADULTS IN SEVEN OF OUR SENIOR HOUSING COMMUNITIES. ASSISTANCE TAILORED TO THE INDIVIDUAL NEEDS OF RESIDENTS, LIKE DAILY MEALS, HOUSEKEEPING AND LAUNDRY AND ONE-ON-ONE ASSISTANCE, ARE OFTEN ALL IT TAKES TO HELP RESIDENTS CONTINUE LIVING INDEPENDENTLY.

To the sons and daughter-in-law who make sure she gets to the many activities she enjoys, and to the Senior Support Services team who make it possible for her to continue living in her apartment at Trinity House in Towson, 97-year-old Iris Dallas is simply “The Queen.”

The title is well-earned, as is the dignity and little indulgences it implies. After all, she spent a lifetime caring for others. Born in Raleigh, North Carolina, in 1920, she raised four sons while her husband, a civil engineer, worked for the State of Maryland and

then in practice on his own. After retirement, the couple spent winters traveling as missionaries in Mexico. About four years ago, her sons helped her move to Trinity House to have her closer to them. Her son Dave knows a lot about Catholic Charities Senior Communities—he lives at Basilica Place in Mount Vernon, where he loves being in the heart of the city.

“I like it here. It’s home to me. I have my apartment with my key, and I know how to use it!” laughed Iris. She loves having the independence to sleep as late as

she likes and eat when she wants, and to stay in her apartment surrounded by the friends she’s made here. She takes long walks in her neighborhood most days, but “The Queen” also appreciates the support she gets from Resident Associate Angela Callum and CHSP Supervisor Tricketya White Satterfield. “Angie does the apartment cleaning for me. I did it for many years, and now I don’t have to. I haven’t even turned on my stove since I’ve been in this apartment. I don’t have to cook, so I’m not cooking!”



Factual Highlights

Community

Assisting all People to Improve their Lives and Become Self-Sufficient

Obtained 377 permanent housing placements for individuals needing a stable place to live.

Secured job placements for 512 people who were out of work. Eighty percent of these individuals were employed earning \$10 or more per hour, 37% were employed earning \$12 or more per hour, and 68% were employed with benefits.

Assisted 44 people in obtaining their U.S. citizenship.

Taught English, computer literacy, and citizenship classes to 622 immigrants to assist with their transition to the U.S. 65% increased their level of proficiency.

Provided affordable apartments and additional services to 1,741 low-income older adults.

Empowered 207 older adults to remain in their apartments and live independently while receiving housekeeping, laundry, personal services and daily meals through the Congregate Housing Program.

Offered 1,620 referrals for service to 512 callers through the Answers for the Aging program.

Served 481,176 meals to men, women, and children in need.

Family

Supporting Children and Families to Secure a Brighter Future

Helped 65 children successfully move from residential care to a less restrictive, family home environment with community-based behavioral health supports.

Operated a special education school that served 164 children. 93% of these students made progress in their reading, math, and/or social-emotional goals based on pre- and post-test results.

Reunited 932 unaccompanied minor children with their families, provided family reunification services to 995 sponsors, and represented 2,056 clients in other immigration legal matters.

Assisted 128 families with international adoptions, 250 families with kinship caregiver support, and 47 children in treatment foster care.

Health

Improving the Health and Wellness for all People in Need

Served 90 older adults and disabled individuals with recreational and therapeutic activities.

Provided bilingual health care services to 1,847 immigrants, including 1,496 adults and 351 children. For 1,038 of these individuals, this was their only source of care other than the Emergency Room. For the patients who received treatment for chronic conditions, 52% (134 people) had their conditions controlled.

Assisted over 9,000 individuals with behavioral health services with 83% of young adults and 68% of adults showing an improvement in their mental health.

Conducted 283 conflict mediations (violence interruptions) by Safe Streets in the Sandtown-Winchester neighborhood. Without these mediations these interactions likely would have resulted in gun violence.
