THREE YEARS AGO, Shakira Hardy and her two children were a month away from homelessness. After her husband was incarcerated, her then-7-year-old son, Anthony, began acting out in ways that confounded educators and mental health professionals. He was suspended from school and hospitalized multiple times. She struggled to keep her job, focused on his needs and those of her then-10-year-old daughter, Aaliyah.

A year ago, Shakira was wrapping small Christmas presents in the cafeteria of a homeless shelter where she and Aaliyah were staying. She had lost her job – and then their home – and they had been kicked out of other shelters because of Anthony's behavior. But, after months of trying, she had secured a spot for him at St. Vincent's Villa – Catholic Charities' residential center for children with significant emotional and behavioral needs. As Anthony received comprehensive treatment, she concentrated on carving out a more stable path for her family.

This year, the holidays will look very different. Now 12, Aaliyah giggles when she thinks about Christmas. She brims with visions of movie nights with holiday classics, homebaked cookies on Christmas Eve, and her own Christmas tree. Her mother beams at her with a proud – and fragile – sense of promise.

We'll all be together Through Baltimore City services, Shakira found Catholic Charities' Project REACH, which offers permanent housing and a path to independence. On June I, she and Aaliyah moved into a three-bedroom home in Baltimore, and Anthony joined them after finishing treatment at St. Vincent's. The holidays offer a chance for renewal, and Shakira pauses when asked about Christmas. "It's going to be the meaning behind it," she said, glancing at her children. "We're going to have our own house and put up our own tree the way we want it. But I'm just elated we'll be all together."

ROSE BEGAN TO NOTICE SERIOUS HEALTH PROBLEMS while she was pregnant with her daughter, Taliah, in 2014. But she was an undocumented single mother with no health insurance and, as she explained, "Nobody wanted to help."

After a friend finally suggested she look into Catholic Charities, she found the Esperanza Center. On her first visit, Community Health Coordinator Wardi Donnelly looked into Rose's eyes and said, "You're pretty sick, you know that?"

The Esperanza team sent her for an ultrasound and a biopsy that identified stage 4 uterine cancer which had spread to her lungs. The center partners with health care institutions like Johns Hopkins, which provided Rose with no-cost treatment.

Today, Rose believes Esperanza Center saved her life, giving her more time to watch her little girl grow. "My lungs are getting better every day," she said. "I give thanks to God, and Miss Wardi, and all the others that have helped."

the Esperanza Center has been operating in temporary spaces after a fire in a neighboring building severely damaged its Broadway facility in September 2018. Despite the relocation, the center continues to provide hope and a wide range of compassionate services to immigrants.

Over the past year, the center has helped reunite 1,445 unaccompanied minors and children separated at the border with family or sponsors, in addition to providing services related to education, health care, legal matters and general support to our new neighbors. Reconstruction continues on the Broadway site, which is expected to reopen in spring 2020.

How mandatory IRA distributions launched a job training program at Gallagher Services

EILEEN LEIKACH WOULD NOT HAVE KNOWN OF GALLAGHER SERVICES if not for her cousin, Bonnie Horwitz.

Yet Bonnie's experiences shaped Eileen's philanthropy in ways that will affect Gallagher clients for years to come.

Bonnie moved into a Gallagher group home more than 30 years ago when she was 17. Her parents, Morris and Libby, recognized they could not provide the care necessary to

support her disabilities. Bonnie had spent most of her time silent, often in front of the TV. The environment and staff at Gallagher's home helped her open up and take on new responsibilities.

Importantly to the family, the Catholic Charities program also honored her Jewish faith. Staff took her and other Jewish individuals from Gallagher Services

to religious services every month. They also supported her bat mitzvah as she turned 13.

Gallagher Services was not just providing Bonnie with clean clothes, good meals, necessary doctor visits, and job training that allowed her to work after reaching adulthood. Rather, the program found ways to understand all of Bonnie's needs.

"They just took very good care of her," Eileen said.

Bonnie passed away seven years ago. Before Morris and Libby's deaths in 2018 and 2019, respectively, Eileen asked about their financial preferences. They included supporting Gallagher Services in recognition of all they had done for Bonnie. When Eileen inherited Morris' IRA, she remembered these conversations. Though she had many financial priorities, she channeled some of the mandatory distributions to launch an employment service that helps people supported by Gallagher Services — and others served by Catholic Charities — find competitive employment.

"I believe in giving," Eileen said, "and I don't need a million dollars."
